Terms and Conditions for the Off-Site Storage of Empty Containers and Trade Show Materials and Price List

Terms and Conditions for the Use of Outdoor Storage Areas

1. **Provision of Storage Areas**

Upon request, the organizer will provide limited outdoor storage areas for the temporary storage of empty containers, packaging materials, pallets, mesh boxes, trade show materials, and similar items.

2. **Condition of the storage areas**

Storage is provided exclusively on uncovered gravel areas in the outdoor section of the exhibition grounds. There is no protection against the elements.

3. **Registration and Allocation**

Use of the storage areas requires prior registration and written confirmation from the organizer. There is no entitlement to the allocation of specific areas. Allocation is subject to availability.

4. **Billing**

Billing is based on the organizer's current price list. Partial square footage or storage units will be billed in full.

5. **Liability**

Storage is exclusively at the exhibitor's own risk. The organizer assumes no liability for:

- Theft or loss,
- Weather damage,
- Damage of any kind,
- Force majeure.

The organizer's liability for intentional acts and gross negligence remains unaffected.

6. **Prohibited Items**

The storage of hazardous materials, highly flammable materials, explosive substances, gas cylinders, chemicals, or other substances requiring a permit is prohibited.

7. **Labeling Requirements**

All stored items must be clearly labeled with the company name and a contact person.

8. **Safety and Order Regulations**

You must comply with the organizer's instructions and all applicable safety and fire safety regulations at all times.

9. Disposal Obligation

All stored Items must be completely removed no later than the end of the event. Any materials left behind may be disposed of at the exhibitor's expense.

10. Right of Access

The organizer reserves the right to reassign storage areas or have them cleared for organizational or safety reasons
